

## STANDARDISED PRICE LIST

All funeral directors are legally required to publish this Price List for a standardised set of products and services. This is to help you think through your options and make choices, and to let you compare prices between different funeral directors (because prices can vary).

<b>ATTENDED FUNERAL (funeral director's charges only)</b>	<b>£2,570</b>
This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.	
Taking care of all necessary legal and administrative arrangements	£1,385
Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care	£160
Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at the funeral director's Alness or Muir of Ord premises, as per the family's request	£350
Providing a suitable coffin – this will be made from oak veneer or wicker, as per the family's choice (other options available on request)	£425
Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer)	£0.00
At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle	£250

### UNATTENDED FUNERAL

This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

<b>Burial (funeral director's charges only)</b>	<b>£1,200</b>
<b>Cremation (funeral director's charges plus the cremation fee)</b> Care and viewing included under the same terms as an attended funeral	<b>£1,800</b>

### FEES YOU MUST PAY

For an Attended or Unattended burial funeral, the <b>burial fee</b> . <sup>1</sup>	<b>£1,003</b>
In this local area, the typical cost of the burial fee for local residents is: For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees.

<sup>1</sup> This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave, or for reopening and closing an existing grave.

## Terms of Business

**Deposit** – Mairi Urquhart & Son require a deposit to be paid equal to the amount charged by the Highland Council for cremation, burial or lair purchase fees prior to the service arranged.

Direct cremation and direct burial require payment in full prior to a funeral date being confirmed.

**Payment terms** – Our invoice will be issued 10 days after the funeral date. We require payment within 30 days of the invoice date. We reserve the right to add 2% interest to any accounts remaining unpaid after 30 days.

We reserve the right to recover legal and debt collection fees should you breach these terms of payment.
